Dear Mr Grech,

Thank you for contacting the European Court of Auditors (ECA) via the Contact committee online form (<https://www.eca.europa.eu/sites/cc/en/Pages/ContactForm.aspx>).

We would inform you that, as established by the [Treaty on the Functioning of the European Union \(TFEU\)](#), the Members Court of Auditors are nominated by their respective Member State. They are then appointed by the Council, after consultation with the European Parliament, and they are sworn in at the Court of Justice of the EU. For further details, you may refer to [Article 285 TFEU](#) and [Article 286 TFEU](#).

Therefore, the scope of the ECA's mandate and powers does not allow it to interfere with the procedure of nomination or appointment of the ECA Members.

Furthermore, please note that the European Ombudsman is competent only as regards cases of maladministration by the EU institutions and has no competence to deal with cases of maladministration allegedly committed by national public servants or national high-level public office holders. For the acts allegedly committed by Mr Hyzler as Commissioner for Standards in Public Life in Malta, you may consider contacting the competent Maltese authorities, including the Maltese Parliamentary Ombudsman: <https://ombudsman.org.mt/the-ombudsmans-mandate/>.

ended sentenced, albeit unjustly, to a mental institution. To get some freedom, I had to appear in front of a Tribunal / Committee responsible for handling cases like mine, and in turn this Tribunal would send the recommendations to the Minister of Justice for the approval. It happened that at that time there was Minister Owen Bonnici at the helm who for several months prolonged my case intentionally, discriminating politically against me, in part because I was associated with blogger / journalist Daphne Caruana Galizia (she was eventually killed in a car bomb on 16-Oct-2017). I have the testimony of 4 persons of this political discrimination against me and even have it sealed proven in emails I sent to these witnesses. Around year 2018, this Minister Bonnici created the office of Commissioner for standards in Public life, and nominated this George Hyzler to be its 1st Commissioner. So I reported to this Hyzler the intentional political discrimination on me by Minister Bonnici. All of a sudden, things progressed significantly in my case, as if to confirm the Minister was made aware it would mean an end of his political career, proceed criminally against him, etc. But this Hyzler didn't take any action against the Minister, instead he covered him up in his crimes (made cover-up of crimes by not reporting, by remaining silent, etc.) for the favour the Minister had done to him nominated him as Commissioner, for as the saying goes, one favour is paid by another. I have in the meantime set up a website full of injustices I had to suffer over the years. In one of the webpages I uploaded the emails I sent to various institutions, those concerning the matter which incriminate both Minister Bonnici and this Hyzler, how the Minister began discriminating against me can be found in this link (<https://tinyurl.com/4zpancm6>), those involving the cover-up by George Hyzler follows in the same webpage and can be seen in this link (<https://tinyurl.com/yuvu4yc2>). The only problem is that the script and the emails are written in Maltese, but it would for sure be worthed their translation to serve as incriminating evidence for both and as a proof of how this Hyzler is for sure not worthy to be nominated to one of Europe's top institutions.
