Following our brief encounter this morning at Mount Carmel Hospital, I am writing to formally address the case I raised with you.

As I explained, I have been subjected to a "mental health" label that originated through documented fraud. This is not merely a medical disagreement; it is a manifestation of the blatant abuses within the psychiatric system — a system that enjoys total impunity while authorities allow whistleblowers, myself in particular, to be targeted for retaliation.

I pointed you toward my website, smashyouagainstthewall.com. As a reminder, the title is a direct quote of a threat made against me by Magistrate Carol Peralta in open court. To save his career, I was subsequently and fraudulently labeled as suffering from "delusions of persecution."

I am left with a disturbing question: How can you remain silent in the face of such documented malice? I ask how you can remain silent about such abuse, as so many of the entities in this email thread have done. I understand you were, and perhaps still are, involved in this thread, yet you have chosen the same path of silence — presumably because speaking out for stigmatized and voiceless patients is an "inconvenience."

Repubblika, like these other entities, claims to walk in the footsteps of Daphne Caruana Galizia, yet your silence mirrors the very institutional hypocrisy you claim to fight. Much like those in the Church who preach Christ's path but look away from suffering, you seem hesitant to tread on the toes of the "big heads" and the well-connected.

The evidence on my website — compiled over years of obstacles and victimization — is more than sufficient; I have effectively done the work of a police investigation. I am asking you directly: Will you continue this "rampant hypocrisy," or will you finally be a voice for the victims of these injustices?
