Whilst wish you the best for the rest of the festive season, I ask if only you can help because I have been wrongly associated with you and am bearing the full consequences (again I am the one who used to nail animals I used to find dead to crosses). This is my ordeal.

I had wrote to Minister of Justice Owen Bonnici in July '14 amongst others to refer me to the tribunal as was the procedure back then but his inexperience told him it should be the Psychiatrist who should write and not the patient. It was only after 2 months in the waiting for nothing that he realised he was mistaken and finally referred me to the tribunal, which tribunal later rejected my plea. Soon later he changed the law (around October '14), took the right from the patient to write directly to the Minister, and made the Psychiatrist the one who should write in the name of the patient. This cost me another 5 months until in March/April '15 the Psychiatrist finally wrote to the Minister to refer me to the newly composed tribunal (after the amendments in law). Rumours had it that I used to write to you who in the meantime had exposed the Minister's extra marital affair (November '14), and seemingly in an act of revenge on me, instead of referring me to the tribunal, he asked for the advice of the Attorney General and the Commissioner of Police (not concurrently but one at a time to further lengthen the process). This was a mere act of abuse of power because he cannot go on to seek the advice of everyone: since the Court had sentenced me to a hospital, common sense makes it that it should be a medical board which examines me and not otherwise. It was only when my relatives called at the minister in January '16 highlighting the fact I was not found guilty by the Court (I had already notified him of this fact in 2 letters dated 14/07/14 and 3/09/15) that he conceded he can do without their advice (of the AG and the Commissioner of Police), and in March '16 he finally referred me to the tribunal after intentionally wasting me more than one year for nothing. This time the tribunal acceded that I be released and forwarded this recommendation to the Minister in May '16. Coincidentally rumours had surfaced again in a MaltaToday article in about March/April '16 that I used to write to you in the past, and abusively the Minister continued not to endorse the recommendation of the medical tribunal. In August '16 I wrote to the Prime Minister lamenting of this abuse of power by the Minister in continually prolonging the process of my release for nothing and he seemingly took revenge again on me by asking afresh for the advice of the AG and the Commissioner of Police for the second time, leaving me stranded for further

many years in detention until they finally respond (a flaw in the system he used to abuse me where the first time after more than one year they still did not respond). In simple words, I am being left kidnapped in detention to satisfy the minister's intense appetite for revenge. This while he was in the Vatican this weekend preaching on moral values and the poor people of Syria who could not celebrate these festivities, and then does exactly the opposite back home for the double face he is. One would ask, if he conceded he could do without their advice in the first time, why did he ask afresh for their advice, an advice which is out of context as I was not sent to a jail but to a hospital, has it not been another mere act of abuse of power. It is ironic that for this Minister, for one who is sent to hospital by the Court he seeks the advice of the medical tribunal, the AG and the Commissioner of Police, and in the meantime keep me locked in detention as if he is some form of judiciary (if this is not breach of human rights I wonder what is), while for one who is sent to jail he seeks the advice of the AG and the Commissioner of Police only, which is a different story for them as these apply while serving their detention to have their sentence reduced. All this while I made him aware in the letter of July '14 of the unfounded accusations the Police made me (with which they framed me up, instigated the hatred of the public against me and portrayed me as a mental/monster amongst others) which makes my case much less severe - instead of launching an inquiry on the Police in the intervening time (he had ample time to do it). Would such mishaps surface in the public he would for sure be forced to resign for abusing his position again and again and being directly involved. The Prime Minister has also much to respond and should carry political responsibility for doing nothing after the letter I sent him in August '16 but back him up. All this cover up and nepotism is deplorable especially considering that I am being played as the sacrificial lamb, paying a hefty price disproportionate to my offences and breaching my human rights, to keep them in position instead of making them face justice for misconduct and mishandling of my case.

The one behind the rumours is Fredrick Azzopardi, Chairman of Enemalta where I used to work who had given me a transfer a fortnight before my arrest of 19/03/14 and soon afterwards was involved in the article which appeared if I am remember well on Kullhadd associating me with you. He uses his friendship with the Minister to infuriate him against me. Azzopardi presumably first got to know of the procedure of my release from the article on me on the Malta Independent of March'15 and contacted the Minister about me. The Minister in March/April'16 got the request from the psychiatrist to refer me to the tribunal but intentionally ignored the request and opted for the advice of the AG and Commissioner of Police to lengthen as much as possible the process. In March'16 the Minister presumably contacted Azzopardi regarding the developments of not going to wait for the advice of the AG and Commissioner of Police any longer, and telling him that he was finally referring me to the tribunal (to further proof how intentionally the Minister was doing it and that everything was embroiled with Azzopardi from the beginning). To this Azzopardi responded with the article on Maltatoday of March/April'16 to incense the Minister again against me as in fact happened, with the latter asking afresh for their advice, again one at a time, to continue to lengthen the process of my release as infinitely as possible.

Anyway if you find me annoying, ignore me, I am not going to bother you again.
