He has already documented his situation extensively, including publishing evidence and correspondence on a website he created. In effect, he has already undertaken much of the investigative work that would normally be the responsibility of the authorities.

It is concerning that despite his repeated attempts to seek assistance from the Police – including emails which remain unanswered or only acknowledged without follow-up – no proper investigation appears to have ever taken place. Instead, responses have sometimes suggested that permission from the very psychiatrists he wishes to incriminate would be required before speaking with him, which seems highly inappropriate.

My intention in writing to you is to emphasize that this case deserves serious and independent investigation. Direct communication with Mr. Grech is essential, rather than relying solely on intermediaries like myself. I also prefer to keep written correspondence via email, as this provides both sides with a clear and verifiable record of communication.

I hope the Police will treat this matter with the gravity it deserves, given the serious allegations of abuse and the potential miscarriage of justice involved.

You exploit this to the fullest, using your victims to satisfy your sadism, and even quoting yourself proudly about inflicting “stress that can cause burnout.”

Meanwhile, the criminals you shield are given leave, discharged, and rewarded with benefits—thanks to diagnoses as fraudulent as your own professional credibility.

This is not just medical misconduct—it is a sustained campaign of abuse. One day, no matter how protected you think you are, justice will demand a reckoning.

If Nicholas had truly written or published anything false or defamatory, Spiteri would have long since taken legal action or forced the removal of Nicholas's website (<https://www.smashyouagainstthewall.com/>) — where he has documented extensive and detailed evidence of psychiatric abuse. Instead, Spiteri chooses to retaliate through unlawful detention, intimidation, and humiliation.

It is therefore obvious that Nicholas is being targeted not for any crime, but for exposing the criminal behavior of those in power — including Spiteri himself.

As always in psychiatry, it is not the abuser who faces consequences, but the victim who dares to speak out.

Nicholas must be given immediate protection from these abusive staff members — especially from Dr. Joseph Spiteri, who clearly views Nicholas as "dangerous" only because he has already revealed enough of Spiteri's corruption to have him jailed for life, if only justice truly applied to people like him.

The Prime Minister, Leader of the Opposition, and both Government and Opposition Whips,

All relevant media outlets, to test whether any of them are still capable of genuine investigative journalism — since lying about Nicholas's case has never been enough for them, even with all the evidence publicly available,

They know perfectly well that Nicholas has always been the first to lend a helping hand in organizing activities. Now let us see whether they will show even a fraction of the same willingness to help him. Thank you for your reply.

I would like to clarify that the matter I raised originates directly from the patient himself, Mr. Nicholas Grech (currently at Mount Carmel Hospital, Male Ward 1, email: [nicho.grech@gmail.com](mailto:nicho.grech@gmail.com)), who is the primary source of the complaints. He has already documented his situation extensively, including publishing evidence and correspondence on a website he created. In effect, he has already undertaken much of the investigative work that would normally be the responsibility of the authorities.

It is concerning that despite his repeated attempts to seek assistance from the Police – including emails which remain unanswered or only acknowledged without follow-up – no proper investigation appears to have ever taken place. Instead, responses have sometimes suggested that permission from the very psychiatrists he wishes to incriminate would be required before speaking with him, which seems highly inappropriate.

My intention in writing to you is to emphasize that this case deserves serious and independent investigation. Direct communication with Mr. Grech is essential, rather than relying solely on intermediaries like myself. I also prefer to keep written correspondence via email, as this provides both sides with a clear and verifiable record of communication.

I hope the Police will treat this matter with the gravity it deserves, given the serious allegations of abuse and the potential miscarriage of justice involved.

It has now been 64 days since my email of 23 July, and not one of the authorities copied here has even acknowledged receipt, let alone initiated an investigation. That silence itself is further proof of the impunity you, psychiatrist Joseph Spiteri, continue to enjoy.

Today, 25 September, also marks the first anniversary of your explicit threat on 25 September 2024 to “chop off his balls” – directed at the patient who dared to expose your corruption and abuses. On that same day, you changed his medication to Risperdal, fully aware it would cause severe erectile dysfunction and lasting suffering. These were not clinical decisions; they were acts of calculated sadism and retaliation.



allegations against you in this article (<https://simonmercieca.com/2021/12/20/one-of-the-reasons-given-for-col-dallis-dismissal-was-because-he-terminated-the-job-contract-of-psychiatrist-joseph-spiteri/>) were truly false? Why not file libel proceedings, arguing—as Delia did—that “the contested publications are defamatory” and capable of causing “serious and damaging harm to your reputation”? Even more so, why not take legal action against someone who has gone as far as dedicating an entire webpage (<https://www.smashyouagainsthewall.com/PsyJosephSpiteriFraudster.html>) to exposing your many acts of sadism and fraudulent practices—if, indeed, any of it were untrue? Why not challenge him in court, especially when you’ve already had him kidnapped into hospital, placed at your disposal 24/7, and subjected to psychiatric abuse under the guise of treatment?

Your silence in both cases only adds to the already substantial body of evidence against you—especially considering the powerful network of allies you enjoy within the legal system, who could have easily helped you clear your name, if that were in any way possible. Instead, unable to deny the truth, you resorted to intimidation: silencing him through countless communication restriction orders (despite the absence of any abuse in his writing that would have warranted removal), threatening him with higher dosages of stronger medication, and subjecting him to humiliating and degrading treatment. One example? Your vulgar threat on 25 September 2024 to “chop off his balls,” which you chillingly followed the same day by changing his medication back to Risperdal—fully aware it would induce erectile dysfunction and other severe suffering.

All of this is rooted in a clearly fabricated diagnosis long ago by your colleague, psychiatrist David Cassar—an invention designed to protect former Magistrate Carol Peralta’s career. You are fully aware of this fraud, as proven in the email ([https://www.smashyouagainsthewall.com/Images/Emails/MW7/MW7\\_23Feb9\\_PsychJSpiteriCEO.pdf](https://www.smashyouagainsthewall.com/Images/Emails/MW7/MW7_23Feb9_PsychJSpiteriCEO.pdf)) this person once sent you. And yet, just days later in March 2023, you responded not with an investigation but with retaliation—issuing a restriction order (<https://www.smashyouagainsthewall.com/Images/Rfc/Rfc04js02Mar23mw7.jpg>) and transferring him to another ward with even fewer liberties, pandering to the appetite for revenge of staff at Male Ward 7, whom he had recently exposed for abuse.

Then, around June 2023, during a supposed “reassessment” by you, David Mamo, and Joseph Saliba, both he and his relatives again detailed how this false label had been maliciously attached to him for years. Despite clear evidence—including official documents and testimonies, many of which are published on his website—you chose to ignore it. Rather than confront the truth, you built further upon the fraudulent diagnosis, keeping him forcibly drugged and detained, while silencing him through vindictive, rubber-stamped orders signed off by your equally complicit ally, Commissioner for Mental Health Denis Vella Baldacchino. All of this as retribution for daring to expose your crimes and the daily abuse occurring within Mount Carmel Hospital, where you serve as Deputy Chairman of Psychiatry.

And while you freely grant unearned social benefits to criminals—further confirming your corrupt practices—you had the audacity to demand that this individual declare himself “sick” (on 6 June 2024 - [https://www.smashyouagainsthewall.com/Images/Emails/Ohti/MW1\\_24Jun\\_OhtiCEOSTXCom\\_HltMenPolMinWhips.pdf](https://www.smashyouagainsthewall.com/Images/Emails/Ohti/MW1_24Jun_OhtiCEOSTXCom_HltMenPolMinWhips.pdf)) just to qualify for basic aid. This was clearly a trap you intended to use as pretext for escalating his medication or applying even more terrifying treatments. That moment marked the beginning of six consecutive restriction orders lasting a total of 168 days—effectively turning his life into a living nightmare, completely isolated from the outside world, without access to emails or social media.

What kind of monster inflicts such cruelty on someone you know to be innocent and already imprisoned—simply because he spoke the truth? While you cozy up to criminals, taking bribes and rewarding them with benefits paid by the public, your treatment of this man reveals exactly who you are. It takes extraordinary resilience and clarity of mind not to lose one’s sanity under the psychological and physical torment you inflict.

And, as always, knowing that the authorities cc’ed here will once again do nothing—despite repeated warnings and extensive evidence—you continue to enjoy the absolute freedom they afford you. You exploit this to the fullest, using your victims to satisfy your sadism, and even quoting yourself proudly about inflicting “stress that can cause burnout.”

Meanwhile, the criminals you shield are given leave, discharged, and rewarded with benefits—thanks to diagnoses as fraudulent as your own professional credibility.

This is not just medical misconduct—it is a sustained campaign of abuse. One day, no matter how protected you think you are, justice will demand a reckoning.

It has now been 48 hours, yet not a single action has been taken – let alone any investigation initiated – despite the severe allegations supported by overwhelming evidence, publicly available online for years. The evidence has been hosted on a website ( <https://www.smashyouagainsthewall.com/> ) that has remained accessible for over seven years without ever being taken down or facing any legal challenge, libel, or defamation suit. Its owner, an ordinary patient, Nicholas Grech, has never been sued. Could there be any clearer demonstration of the impunity enjoyed by those in high positions in Malta – where duty is conveniently set aside whenever it concerns incriminating the powerful, who are instead left to abuse their positions even further, unrestrained and with total impunity, while their victim Nicholas remains drugged, locked up, and kidnapped inside a mental facility under a completely fraudulent psychiatric diagnosis fabricated over two decades ago to save a corrupt magistrate's career?

In the same spirit of cruelty and abuse, the "cruel" and "dangerous" nursing officer Sandro Cortis, now desperate to save his own job following the exposure of a recorded incident, has hastily ordered a blood test on Nicholas to check for traces of the venomous drug Risperdal – vindictively prescribed on 25 September 2024 to make him suffer from erectile dysfunction. This was done deliberately, following threats from Spiteri himself on that same day, when he explicitly stated that "in an instant he would chop off his balls." It is no secret that psychiatric drugs are often prescribed for their side effects rather than any supposed healing purpose. Cortis was present during this act of blatant abuse, backing and rubber-stamping Spiteri's orders with yet another restriction ( <https://www.smashyouagainsthewall.com/Images/Rfc/Rfc09js25Sep24mw1.jpg> ) order imposed on Nicholas – just as he was present on 6 June 2024 ( <https://www.smashyouagainsthewall.com/Images/Rfc/Rfc05js06Jun24mw1.jpg> ), when the same fraudulent Spiteri pressured Nicholas to "admit he is sick," to fraudulently entitle him to social benefits ( [https://www.smashyouagainsthewall.com/Images/Emails/Ohti/MW1\\_24Jun\\_OhtiCEOSTXCom\\_HltMenPolMinWhips.pdf](https://www.smashyouagainsthewall.com/Images/Emails/Ohti/MW1_24Jun_OhtiCEOSTXCom_HltMenPolMinWhips.pdf) ) for the false diagnosis – a diagnosis Spiteri knows perfectly well was maliciously created to protect Peralta's career.

This email thread is now being forwarded internationally – to European institutions, public figures, and foreign embassies in Malta. The Ombudsman's reply this morning, advising "to first resolve any grievance with the responsible authorities," is beyond absurd given the record shown in this same thread. The authorities – including the Police – were already contacted on 23 July, 25 September, and again on 12 October, yet all in vain. Not a single investigation was launched, no one was prosecuted, and Nicholas continues to be abused and drugged at will.

Once again, this proves how local authorities in Malta are always quick to produce excuses to avoid investigating when doing so would implicate the powerful – the "big heads" and their friends. From the link already provided last Sunday ( <https://www.smashyouagainsthewall.com/EmailsLetters.html> ), Nicholas himself has repeatedly appealed for help to countless institutions – including the Office of the Commissioner for Mental Health and the Ombudsman's Office – yet nothing has changed.

Meanwhile, as “The Office of the Ombudsman remains available to review matters only once all internal avenues of complaint and resolution have been exhausted,” Nicholas will likely by then be too disabled – if not dead – from the continued administration of these venomous psychiatric drugs. Those responsible clearly have every interest in ensuring such an outcome, to protect their jobs, reputations, and freedom from facing justice for their abuses, misconduct, and their corrupt, sadistic, and fraudulent practices.
