English translation:

- **Question:** *I wanted to ask where and when you see private patients, as I would like to come and speak with you.*
- **Psychiatrist Anton Grech:** *St. Mark's Clinic, Msida and Capua, Sliema.*

Note how corrupt he is, as confirmed by this email. When he was asked at his government email address (anton.grech@gov.mt) about his supposed full-time, taxpayer-funded job with the Government and where he works privately, his insatiable greed for money made him forget that, in that role, he is obliged to devote his working hours to his employer, the Government. He shouldn't even have replied to that email, which was not related to his work (note the word "External" in the subject — an alert automatically added by the Government email server), or at most he should have informed the enquirer about the services he provides for the Government. Is he implying that the services he provides to the Government are of lower quality than those he offers privately? He should use other means, at his own expense and when he is not at the workplace, to advertise his private practice so anyone interested can easily find it. Of course, don't expect the authorities to take action against him (they will invent excuses to excuse him), but I assure you if an ordinary person had done the same it would have been a totally different story — they would take drastic action against you to set an example.

Once again: if you are considering seeing a psychiatrist, remember not to take an empty wallet with you. (as apart the cost of the pills he prescribes, even the clinic/pharmacist wants their share.) Expect him to suggest follow-up visits again and again (and again bring that wallet). This is my advice; I may be wrong. But if you are going through a difficult time, rather than seeking psychiatric help and risking experiencing the racket and abuses behind this so-called profession, why not first try adopting an animal — particularly a cat — and you may be astonished by how much joy it brings to your life and home. If you dislike having an animal, then by all means go

and ruin your life and your wallet at the hands of a psychiatrist. In the long run I am convinced you will regret it.
